Asynchronous Digital License – 3 Year
STANDARD TERMS AND CONDITIONS

1. Grant of License: Upon receipt by Licensor of this Agreement, signed by Licensee, Licensee is granted by Licensor a non-exclusive, non-transferable license to digitize the Programs and use them only in a Closed Synchronous/Asynchronous Delivery System limited to the Territory. (e.g. Licensee may stream the digital content from a server that is accessible anytime by multiple users and multiple locations within the Territory, a video-on-demand environment, OR Licensee may stream the digital content from a server with simultaneous delivery to multiple locations within the Territory.)
2. Territory: This license permits Licensee to stream the password-protected, digital content to locations outside of the territory only to faculty, staff, or students who are officially registered for courses with the Licensee or who are officially employed by Licensee and only via IP or VPN authentication. Any contemplated use of the Programs outside of the Territory will require a supplementary license from Licensor.
3. Security: Licensee shall provide adequate security to prevent theft, pirating and unauthorized exhibition, duplication or copying of the Programs. Licensee will stream the digitized content only to authorized users within the Territory; ensure the content remains password-protected; and make certain that the Programs will not be able to be downloaded to or captured in any permanent way by students' computers or digital recording devices. Licensee will publicize a copyright policy regarding its digital programs prominently in its service area. Licensee shall give prompt notice to Licensor of any unauthorized activity.
4. Payment: Licensee will make all payments due to Licensor within 30 days of receiving the invoice.
5. Terms: The license granted to Licensee under this Agreement shall commence from the date of purchase of each file and remain in effect until the date of expiration printed on the sales invoice. If the format of delivery (mpeg-4 files) becomes obsolete, then a new, mutually acceptable license must be negotiated.
6. Delivery & Return of Digital Programs: MEF will deliver, within 10 days of the signing of this Agreement, (a) link(s) with a downloadable MPEG-4 copy of the Programs to Licensee, which the Licensee can encode into the streaming format of Licensee's choice.
7. WARRANTIES: MEF warrants that it possesses the necessary rights to the Programs to enter into this Agreement and to grant a digital license to Licensee and carry out the terms hereof. MEF further warrants that the Programs, and Licensee's digital streaming of them hereunder, do not, and will not, infringe any statutory or common-law copyright or other intellectual property right of any third party.
8. Successors and Assigns: This Agreement shall be binding upon and shall inure to the benefit of the respective successors of the parties hereto, provided that this Agreement may not be assigned without the consent of all parties hereto.
9. Complete Agreement: This Agreement, including all schedules hereto, constitutes the entire agreement between Licensee and MEF and may not be altered or amended except in writing, signed by each of the parties.
